The Amount of loan must be in the sum of \$100 or any multiple thereof and must not exceed 75% of the total cost of the drainage work or \$50,000.00.

FINAL LOAN AMOUNT MUST NOT EXCEED THE AMOUNT APPLIED FOR ON THIS APPLICATION. IF FINAL COSTS EXCEED THIS AMOUNT, ANOTHER APPLICATION MUST BE SUBMITTED FOR APPROVAL.

In making this application for a loan, I understand and agree to the following:

- (a) The granting or refusal of the application is in the discretion of council whose decision is final;
- (b) I hereby acknowledge receipt of a copy of the *Tile Drainage Act, R.S.O. 1990, Chapter T.8* and that I am aware of the content of the said Act and that I will comply with the requirements set out in the Act;
- (c) All outlet pipes installed shall be non-perforated pipe at least 3 metres long & shall be embedded 2.5 metres into the bank of the drain & shall protrude .5 metres beyond its face. The outlet end shall be fitted with a removable wire rodent guard. All fresh dirt from the work must be removed from open drains.
- (d) All work must be carried out in accordance with the *Agricultural Tile Drainage Installation Act, as amended*.
- (e) An inspector of drainage appointed by council will report to council to the effect that the work has been satisfactorily completed before any funds are advanced by way of loan. A map of your tile drainage must be submitted to the Tile Drainage Inspector when inspection is completed;
- (f) Council shall levy and collect for the term of ten years over and above all other rates upon the land, in respect of which the loan is made, a special equal rate sufficient to discharge the principal and interest of the loan;
- (g) The Tile Drainage Act sets out procedural matters concerning apportionment of a loan when part of the land is sold, discharge of the indebtedness upon repayment of the loan at any time and all other matters which pertain to this application for a loan; and
- (h) In signing this document, I certify that I have not applied for or received in excess of a total of \$50,000.00, in this or any other municipality in the fiscal year of April 01 to March 31 of the following year.
